DEADLINE DATES

- March 5, 2012** **7:00pm - Men's & Co-ed Recreational Leagues Organizational Meeting**
Team registration starts for all teams.
A \$50.00 deposit is required to secure your requested league night.
This deposit also serves as your \$50.00 refundable forfeit fee.
- March 16, 2012** After \$50.00 deposit is paid, receive a 10% discount on the \$345.00 sponsor fee, if paid by this date.
Pay only \$310.50.
- April 2, 2012** The \$345.00 sponsor fee is due for ALL TEAMS!
If this fee is not paid on time, a \$20.00 late charge will be added to the sponsor fee.
- April 20, 2012** **Player fees and contracts due. (\$25/player fee)**
(No transactions can be made on the field!)
- April 30, 2012** Season Starts! Any new players added after their team's first game must add \$2.00 to their player fee.
- May 25, 2012** NO new players may be added to the roster (unless permitted by the league director).
- June 1, 2012** MASA Team Registration State Tournament forms must be in Midland, MI by this day (this form will be handled by the recreation department).
- July 2, 2012** If you are interested in playing in the MASA State Championships, please contact, Dan Cooperrider, League Director, as soon as possible prior to this date.

GENERAL INFORMATION – ALL LEAGUES

1. Please make all checks for deposits, sponsor fees, and player fees payable to: **PITTSFIELD TOWNSHIP**
2. Please observe all deadline dates in order to avoid penalty
3. All transactions will be made through the Recreation Department. No player fees or contracts will be handled on the field.
4. **Practice times** for your team will be handled by the Recreation Office. The policy is as follows:

Teams are limited to one practice per week on Diamond # 1 and one on Diamond # 2 at Montibeller Park. Practices are also available at the Pittsfield Township Park field until May 14. The practices are for a period of 1 ½ hours per practice. They are given on a first come first or call basis on Monday morning at 9:00am or anytime that week.
(Practices times are made for that week only. A week is considered Monday through Monday!)
5. If you would like to sponsor a tournament, please contact the Recreation Department as soon as possible.
6. If your team is interested in playing in any MASA state qualifier, district or state championship, an ASA Official Championship Roster form must be filled out on-line. Forms are on-line at **www.masasoftball.org** For questions, contact Dan Cooperrider, MASA At-Large Commissioner # 6, at the Pittsfield Twp. Parks & Recreation Office. Ask about deadline dates!
7. Parking can be a problem at the park sometimes. Please park in designated parking spaces!
